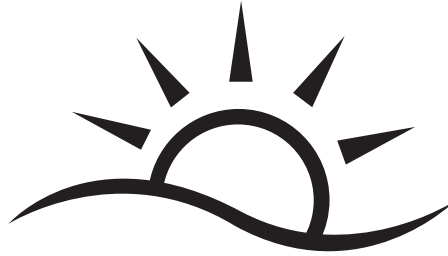
- ✓ This agreement needs to be signed by the CAGP-ACPDPTM member (organization) and the CAGP-ACPDPTM National Office.

The undersigned CAGP-ACPDP™ member who wishes to use LEAVE A LEGACY™ registered program materials agrees to the following:

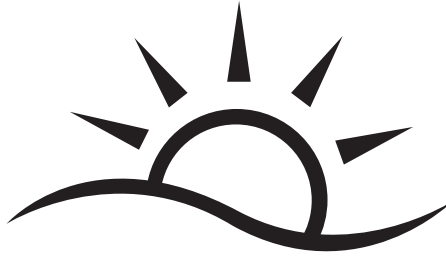
All rights, title and interest in and to the Trademarks are owned by NCPG® and under license to CAGP-ACPDP™. The Trademarks can only be used in connection with programs and materials authorized by the Canadian Association of Gift Planners (CAGP-ACPDP™).

The **CAGP-ACPDP™ National Office** authorizes the use of the Trademarks locally by the CAGP-ACPDP™ member in connection with the registered material. The registered materials cannot be changed or tampered with in any way. The member agrees to submit any non-registered material samples including publicity, advertising and print materials, whether written or electronic, containing the Trademarks. A single organization or multiple chapters or affiliates of a single organization cannot use the Trademarks other than the CAGP-ACPDP™ member, the organization office they represent, or the partners of a registered local LEAVE A LEGACY™ program.

Description and Use of Trademarks

The CAGP-ACPDP™ member agrees to comply with the standards of quality for usage of the Trademarks as set forth in the Guidelines for Use of LEAVE A LEGACY™ & Sunrise Design Trademarks attached hereto (the “Guidelines”). The CAGP-ACPDP™ member agrees to submit proofs of non-registered material to the CAGP-ACPDP™ National Office for approval prior to production.

CAGP-ACPDP™ has the right to amend the Guidelines at any time and to terminate this agreement at its discretion.
